Retiree's Corner

I have gone through the NALC retirement manual and written articles on each chapter, but even though I have covered some subjects numerous times, I still get the same questions, so I have come to the conclusion that many carriers who are still years away from retirement probably skip my articles. Since I believe this is the case, and that knowing about retirement is important, I have decided to repeat those articles. This month's article originally appeared in the August 2006 newsletter and was updated 1/8/2019.

As a matter of fact, I had a discussion with a carrier at the January meeting on this very topic.

This month, we will discuss Medicare and how it fits with your health benefit plan. There are four parts of Medicare, parts A, hospital insurance, part B, medical insurance, part C Medicare advantage and Part D Prescription drug coverage.

Part A is Hospital insurance and if you have worked for 10 years or more in medicare employment, you should be able to receive part A with no premiums, and the USPS came under medicare in 1983.

Part B is Medical insurance and is fee based. You can sign up for it during your initial enrollment period which is 3 months before the month you turn 65, and 3 months after the month you turn 65. If you don't sign up for it then, you can sign up in any open enrollment period which is January through March of each year. **Caution**; decide if you want it before you turn 65. If you don't sign up for it during your initial enrollment period, your part B premium will go up 10% for each 12 month period you were eligible but did not have it.

If you have part B and FEHB, benefits will be coordinated between the two, with FEHB as your primary payer if you are still working, and part B as the primary payer if you are retired.

The question then is, if you have FEHB, should you sign up for part B? That is a question only you can answer, and each individual should look into this very carefully. Get a list of what part B covers and what your FEHB plan covers, and compare them.

Health Benefit Report/ MBA Frank Costa

SPORTS EYE PROTECTION: For

Parents and Coaches of Young Athletes.

Eye injuries don't have to be part of the game. The facts are, More than 600,000 eye injuries related to sports and recreation occur each year. Over 85% of children do not utilize protective eyewear in situations that represent a risk of eye injury. Every 13 minutes a person with a sports related eye injury visits an emergency room. More than 90/% of all eye injuries can be prevented with the use of appropriate protective eyewear. Many organizations, researchers, and Individuals strongly advise the use of Protective Eyewear: The American Academy of Pediatrics, American Academy of Ophthalmology, American Optometric Assoc., American Public Health Assoc., and The Coalition to Prevent Sports Eye Injuries, National Eye Institute.

BUYING TIPS: Use the recommended eye protection table to find the eye protection safety standard for your sport. Ensure that the protector you purchase meets or exceeds that recommended standard. For outdoor sports, insist on 100% UVA & UVB protection. Additionally, photochromic (lenses that change color) or tinted lenses are excellent for sports various light situations. For both indoor and outdoor sports, anti-reflective coatings add comfort by reducing glare. Frames must be used with a sports band or retention strap to ensure the frames stay in place.

YOU CAN TAKE ACTION. Help prevent a child from becoming an eye injury statistic. If you are a parent, guardian, coach or sports program director of young athletes, you are responsible for the safety of their eyes while participating in sports with known eye injury risks. For the children who need corrective prescription lenses, it is important to know that regular eyeglasses and contact lenses provide little or no protection. In fact, regular evewear may even cause a more severe eye injury. Talk to your eye care professional about protective sports eyewear with your prescription. While no single device can prevent all injuries, sport eye protection that meets stringent ASTM standards for the sports being played can significantly reduce the risk of sportrelated eye injury.





Assaults at Work - Last month I wrote about a Lynnwood carrier that was robbed at gun point. If you follow the Postal news that appears, you will see that unfortunately throughout our nation Letter Carriers are assaulted, robbed or even worse. A good article to read about this appeared in the March 2015 edition of The Postal Record (page 34) and written by Kevin Card of the Compensation Department.

M-1870 is the latest in Memorandums that cover CCA's. You can go to NALC.org and read it and get info that may be important to you. These are questions that I have been asked about lately by CCA's.

32. Do CCAs that are converted to career status carry their annual leave balance over when hired?

No. Currently, CCAs receive a terminal leave payment for any leave balance at the end of the CCA appointment.

33. Are CCAs covered by the Memorandum of Understanding, Re: Bereavement Leave?

Yes, however, CCAs do not earn sick leave and therefore may only request annual leave or leave without pay for bereavement purposes.

As you read this, I am no longer the Branch President. I will help President Michelle in any way that I can. And, I hope to continue to be of service to Branch 791 in the future. Thank you for allowing me to serve over the years as your president. It has been and honor and a privilege.

BASEBALL: ASTM Standard F910 (Face Guard attached to the Helmet) (Batting/Base

Running), ASTM Standard F803 for Baseball, (Fielding).

BASKETBALL: ASTM Standard F803 for Basketball. (ASTM Specifies Age Ranges)

RACQUETBALL: ASTM Standard F803 for Racquetball.

SOCCER / SQUASH: ASTM Standard F803 for Soccer and Squash.

FOOTBALL: Polycarbonate Eye Shield Attached to Helmet Mounted Wire Face Mask.

VOLLEYBALL: ASTM Standard F803 for Basketball

LACROSSE: ASTM Standard for Lacrosse.

There may be things that plan B will cover that your particular FEHB plan does not. Another thing to look into is, if you are retired and plan B will become the primary payer, would you want to switch to another FEHB plan that is cheaper, or switch from your existing high option plan to low option?

Check all this out very carefully. For 2019, the enrollment for plan B (during your initial enrollment period) is \$135.50 per month (or higher depending on your income). You can get more information on Medicare at 1-800-MEDICARE or www.medicare.gov.

Part C is Medicare advantage and is a supplemental plan sold by insurance companies to cover what is not covered by Medicare. This is basically what your FEHB plan becomes when you retire and are under Medicare.

Part D is prescription drug coverage. If you have an FEHB program, you will probably not need Part D.
